- Copyright is the exclusive and assignable legal right given to the originator, for a fixed number of years, to print, publish, perform etc.

  - Ornament or composition of lines or colours applied to any article
  - Two or three-dimensional form, or both

**Learning Outcomes for the Activity:** Anything that is created out of a person's intellect is Intellectual Property. Students and Faculty members were able to understand

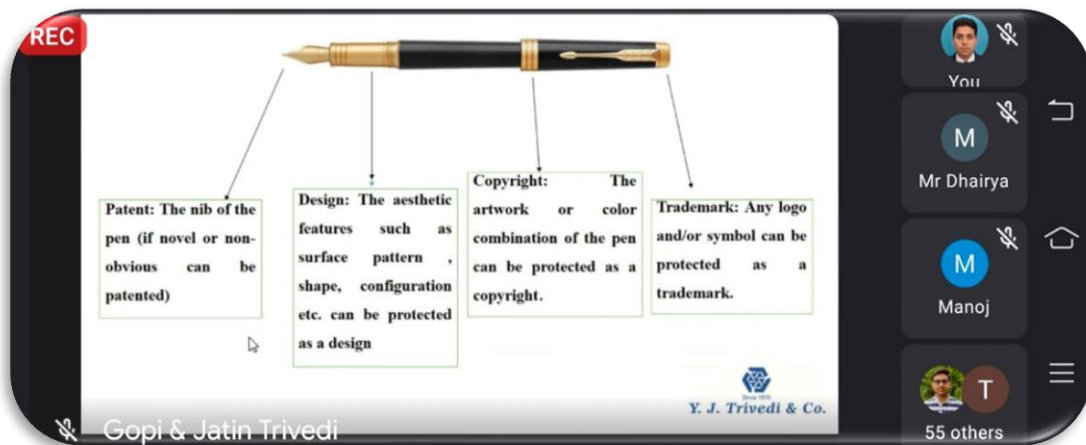
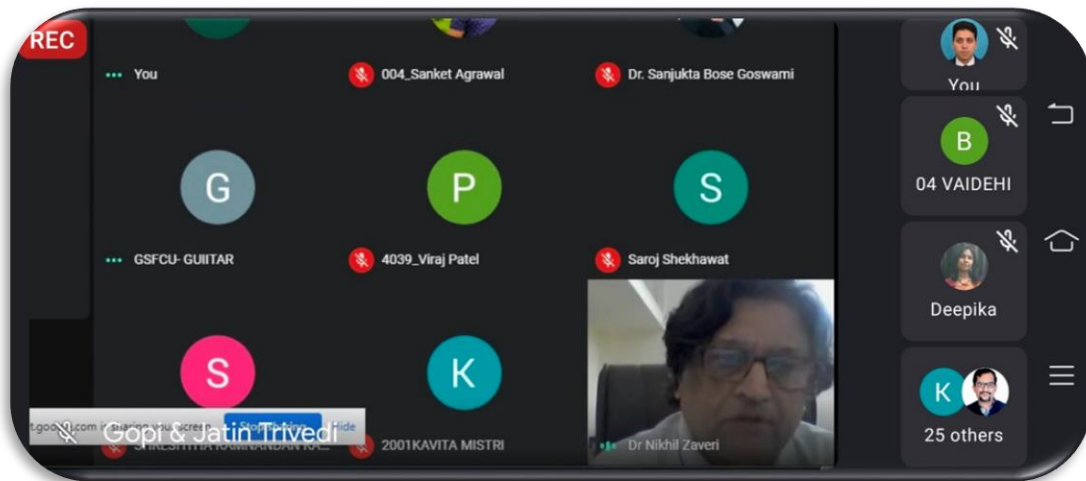
- The need to protect IPR
